
Summary

Overview:

In partnership with the Cleveland Department of Public Health (CDPH), Feed Our Future (FOF) held listening sessions with Cleveland growers to better understand their lived perspectives and experiences on urban farming for farm to school.

Goal:

To inform two strategic areas:



Key Take -Aways:

- There is a lack of transparency of the farm to school resources available to Cleveland growers.
- Technical assistance with the bidding process and grant writing is needed to support growers access to institutional markets.
- Develop structured programs steps and milestones.
- Clarification with what is needed (certifications, product specifications, etc.) for the school supply chain.
- Clear and concise instruction on what schools are looking for to build a relationship with a producer.



Background for Listening Sessions

FOF and CDPH conducted listening sessions to collect qualitative data to better understand the perspectives of Cleveland growers. The insights gained from these sessions will be used to inform and adapt current farm to school strategies and inform strategic growth for urban growers for farm to school.

The Goal:

The goal of our listening sessions was to inform 2 strategic areas of our farm to school work:



The Why of Local Foods: Why are you interested in selling your food to school districts?



Opportunities for Farm to School: What challenges and barriers continue to exist that make it difficult to join this space?

The Process:

STEP ONE:

Online survey to gauge the perspective of farm to school from urban growers in Cleveland.

STEP TWO:

In-person conversations to discuss the 2 strategic areas and to create space that allows urban growers to share their perspective of farm to school with FOF and CDPH.

STEP THREE:

Virtual meeting space to create an opportunity for those growers that were unable to attend in-person sessions.

STEP FOUR:

Report out findings and recommendations to Cleveland growers.




The "Why" of Local Food

FOF and CDPH understand how important it is to know why Cleveland growers want to sell their food to schools in their community. By asking this question, we want to know what drives Cleveland growers to sell their food to schools and what impact growers hope to make with these partnerships.

What We Learned from the Survey:

When asked if growers have tried to sell their food to schools, *2 respondents answered no and 3 respondents answered yes.*



When asked why growers want to sell their food to schools the top three answers include: **5 Cleveland-growers want to support families in their community; 4 want to provide healthy food to kids in schools; and 4 want to create a more sustainable food system in their community**.

Opportunities for Farm to School

FOF and CDPH recognize that there are barriers that keep Cleveland growers from selling their food to schools in their community.

The barrier that is most experienced by Clevelandgrowers is obtaining necessary certifications to enter the school supply chain.



What We Learned When We Dove Deeper:

- Certification requirements are the biggest barrier.
- There needs to be increased visibility of farm to school programming and Feed Our Future.
- Engage the Food Leaders Alliance to spread awareness of farm to school.
- Utilize flyers, social media, and testimonials to spread awareness
- Not only providing produce but sharing the story and experience.
- There are concerns with balancing feeding the neighborhood and also feeding the schools, there has to be a diverse revenue stream for urban growers.

How would you want to build partnerships with local governmental agencies?

• Introductions to farm to school team

How would you want to build partnerships with school districts?

- There are growers that work on the education aspect of farm to school, but don't work with them on sourcing food. Outreach to school administration to understand who these growers are.
- Clarification on if schools can purchase from school gardens to produce revenue for school programming.
- There needs to be more transparency about what schools are looking for and what requirements are needed to enter the school supply chain.
- Publicize information to spread awareness



Opportunities for Farm to School

What We Learned When We Dove Deeper:

What kind of support or resources would make it easier for you to sell to schools?

- Technical assistance with bidding process
- Help with funding opportunities (grants, scaling resources)
- Develop structured programs with steps and milestones
- Access to food safety-certified kitchens to prevent cross-contamination
- Adding the Farm to School Readiness Plan survey to the Feed Our Future website.
- Share information regarding how to price their products for the supply chain.
- Understanding minimum amount of product that needs to be grown for school supply chain

Recommendations:

	Connect growers with Food Safety Consultant and Food Safety Information.
	Increase visibility of local governmental resources and farm to school programs at community events.
